

PRIVACY AND COOKIE POLICY

PRIVACY STATEMENT

This Privacy Statement has been updated in accordance with current data protection policies, including the General Data Protection Regulation (GDPR) and the ePrivacy Regulation. It outlines the types of data collected by IET, the purposes for which they are used, and the rights of the user.

Who does this privacy statement apply to and what does it include?

This Privacy Statement applies to all IET entities with their registered office at Piazza Santiago del Cile 8, 00197, Rome (RM). IET is committed to handling user information transparently and in compliance with applicable regulations.

This Privacy Statement explains how we collect, process, store, and protect user information when using the "IET Website" or during any other activities that are an integral part of the company's operations. When referring to the "IET Website" in this statement, we mean the webpages of www.iet.it.

What kind of data does IET collect?

As a visitor to the website, you are not required to provide any personal information to browse. However, IET may collect data such as your name, email address, IP address, and other personal information when you interact with the website. To ensure the security and proper functioning of the site, we use cookies and other tracking technologies, in compliance with our cookie policy. Typically, IET does not request sensitive personal data from users. If necessary, IET will obtain the user's consent to collect and use such information.

IET does not engage in collecting personal data on online activities conducted by third-party websites or online services, nor does it allow third parties to collect personal data while users are navigating the website. IET understands the importance of protecting children's privacy. The IET website and services are not intended for children, and it is not IET's policy to knowingly collect or store data related to children.

How does IET use data about you?

The personal data provided to IET may be used to manage the relationship with the user, including any requests made by the user to customize or improve the website and its related



services. Personal data may also be used to protect the rights or property of IET or its users, and to comply with legal procedures, if applicable.

Legal Bases for Data Processing

IET processes personal data based on one or more of the following legal principles: (a) explicit consent, (b) contractual necessity, (c) legal obligations, and (d) legitimate business interests, balanced against the rights of the user.

Sharing and Disclosure of Personal Data

IET may share personal data with members of the IET network and third-party service providers, ensuring adequate protections are in place, particularly for transfers outside the European Economic Area (EEA). The IET website may host various blogs, forums, wikis, and other social media applications or services that allow users to share content with others. It is important to note that personal data provided by the user to social media applications may be read, collected, and used by other users of such applications. IET has little to no control over other users and, therefore, cannot guarantee that the data provided by the user to social media applications will be handled in accordance with this privacy statement.

In any case, IET may be required to disclose personal data to comply with legal obligations, upon request from a regulatory authority or during legal proceedings.

Protection of Personal Data

We implement physical, technical, and organizational measures to safeguard personal data, such as: continuous training of relevant staff to ensure they are aware of confidentiality obligations when handling personal data; administrative and technical controls to limit access to personal data based on the "need-to-know" principle; the use of firewalls, encryption, and antivirus software; and restricted access measures.

Although IET employs appropriate security measures once personal data is received, transmission of such data over the Internet (including via email) can never be entirely secure. IET strives to protect personal data but cannot guarantee the security of data transmitted to or from IET.



Data Retention Period

Personal data will be retained for the duration necessary to fulfil the purpose for which it was collected, to comply with legal obligations, or until the end of any potential dispute period.

User Rights

The user has the right to access, rectify, delete, restrict the processing, or object to the use of their personal data. They also have the right to data portability and to lodge a complaint with the relevant supervisory authority.

This site uses cookies to ensure an optimal browsing experience. We use necessary, functional, and performance cookies to analyse traffic and improve the site. User consent is required for the use of non-essential cookies.

How can cookies be controlled?

After reviewing this Cookie Policy, IET will seek the user's consent to place cookies on their computer or other devices as outlined above. Users can control and manage cookies in various ways. Most browsers allow users to control which cookies are present and to delete them individually, or to block cookies from all/any websites. However, please be aware that any preferences set will be lost if all cookies are deleted, including the preference to opt out of receiving cookies, as this requires setting an opt-out cookie. Managing locally shared objects or Flash Cookies
